Permission transfer production license P8a; accession Petrogas E & P Netherlands BV, Ministry of Economic Affairs

Procedure:

- Van Dyke Energy Company (Van Dyke) is the holder of by order of the Minister of Economic Affairs (hereinafter: EZ) granted authorization to extract hydrocarbons from October 20, 2006 with reference ET / EM / 6,085,689 (Government Gazette 2006, no.. 214) for a portion of block P8 (P8a) of the continental shelf, which block is shown in the Annex 3 to the Mining Regulations attached map;
- This production license P8a was last amended by Decision of July 7, 2014 with reference DGETM-EM / 14,105,061 (Government Gazette 2014, No. 20 493..);

- The license holder, in a letter dated July 21, 2015, received on the same date, requested authorization - under Article 20, first paragraph, of the Mining Act (hereinafter MBW) - to transfer the production license P8a to Petrogas E & P Netherlands BV (hereinafter Petrogas), such that Petrogas and Van Dyke after transfer jointly licensee;
- The licensee has requested in the same letter of July 21, 2015, directly to transfer Petrogas to be designated as the provider performs the work or commission them, as referred to in Article 22, paragraph MBW.

Having regard to:

Article 20, first and third paragraphs, of the Mining Act, in conjunction with Article 22, paragraph, of the Mining Act.

Decision:

Article 1

The holder of the production license hydrocarbons P8a,

by a decision of October 20, 2006, with reference ET / EM / 6,085,689 (Government Gazette. 2006, no. 214) granting authorization to transfer the license to Petrogas E & P Netherlands BV and Van Dyke Company jointly.

Article 2

From the time of transmission is Petrogas E & P Netherlands BV, the person who performs or has given its assignment, the actual work as referred to in Article 22, paragraph Mining

Article 3

The permission referred to in Article 1 shall expire one year after publication of this Decision.

Article 4

The licensee does the transfer prompt written notice to the Minister of Economic Affairs and EBN BV, Legal Department, Daalsesingel 1, 3511 SV Utrecht.

This Decision shall enter into force on the day following that on which the decision was announced.

This Decision is published by forwarding to the applicant. Of this Decision shall be announced by publication in the Government Gazette.
